Valleyview Co-op will award one (1) bursary valued at \$500.00 to a Grade 12 student whose parent or guardian is actively employed at Valleyview Co-op.

The following criteria will be taken into consideration when making decisions as to the bursary recipient.

1. The applicant must be a Grade 12 student whose parent or guardian is an employee of Valleyview Co-op. The parent or guardian must be actively employed with Valleyview Co-op since January 1st of the award year. Employees on leave do not qualify.
2. The Valleyview Co-op employee must maintain a job performance rating of Fully Achieving Performance in order for their children to qualify.
3. Selections will be completed by the Member Relations Committee who will rate applications based on financial need, long term plans and goals, and school and community involvement activities.
4. Applicants must submit proof of enrollment in a post secondary program by June 30th of the their graduating year or if opting to not to attend post-secondary education immediately after graduation by June 30th of the following year to qualify for payment. In this case, the student must inform Valleyview Co-op in writing of their intention to pursue education at a later date.
5. Applicants must provide a completed application form in order to be considered for the award.
6. **Application must be received by May 15th of graduation year.**
